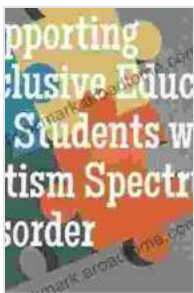

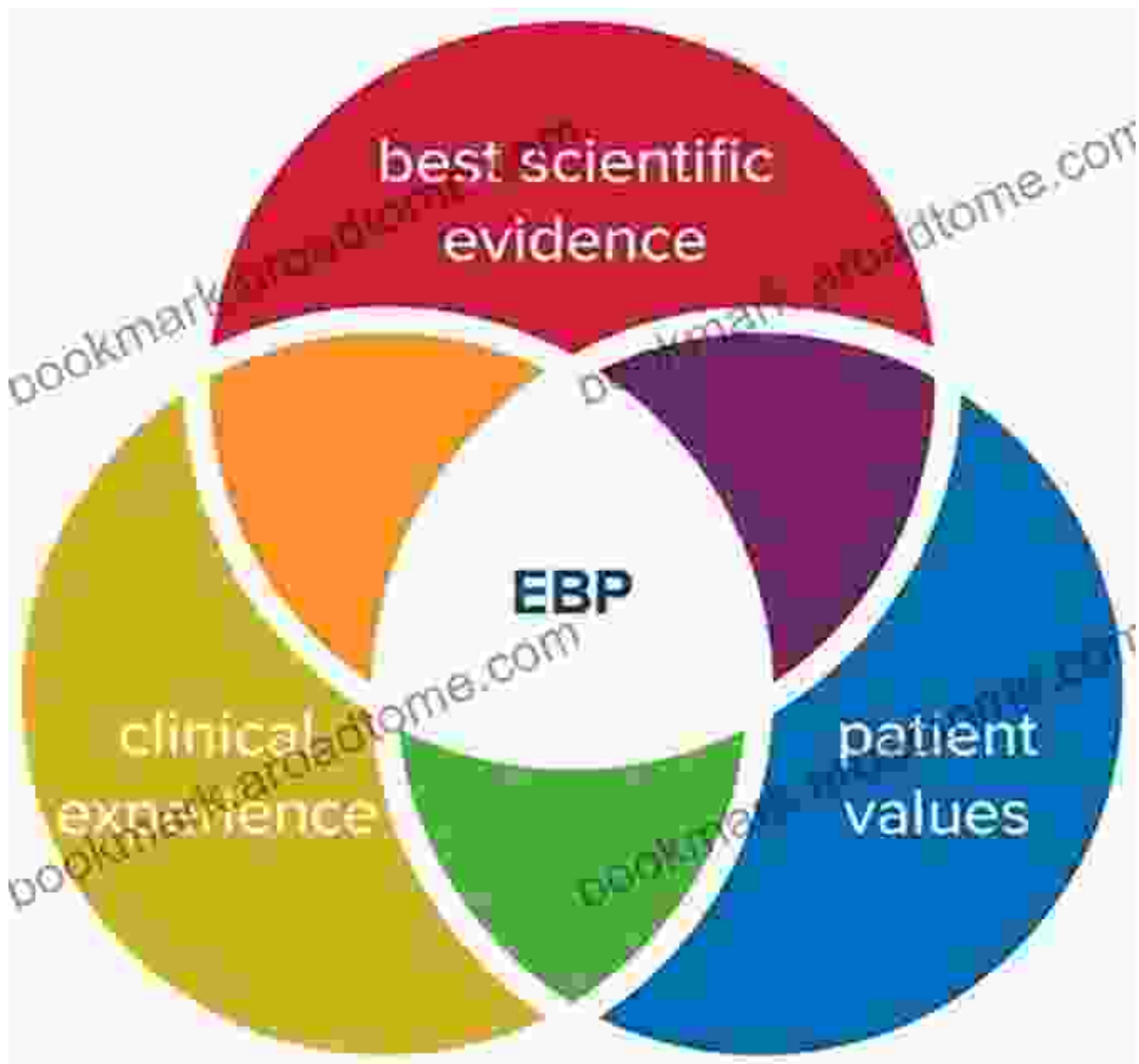

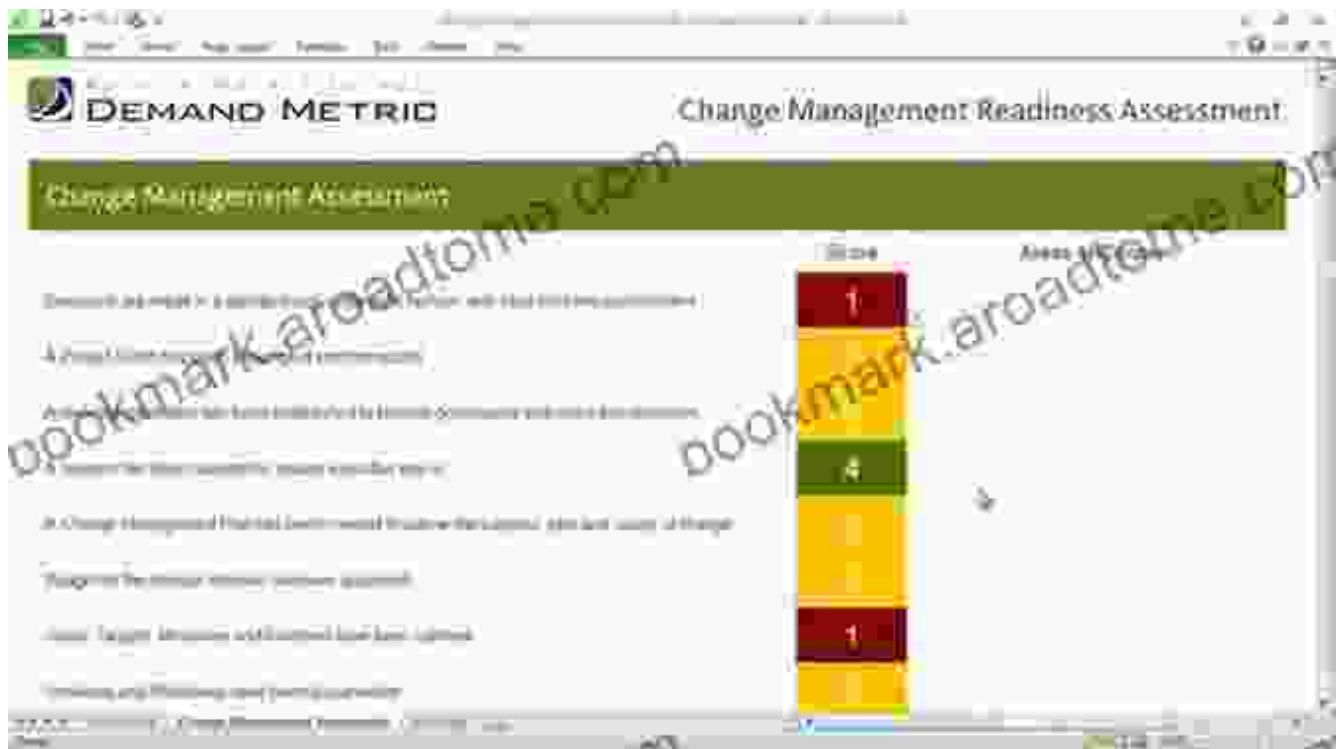

Example of a Phase-In Approach

A phase-in approach is suggested below. MAA-ODA, the contractor and Governing Council can jointly determine the exact parameters of each phase during the implementation process. The baseline assumption is that each phase will be spaced one month apart. Start firm case management through APS should be incorporated in Phase I. Information and Assistance services are going to be minimal until Phase V, as the phone number for the Resource Center will not yet be distributed.

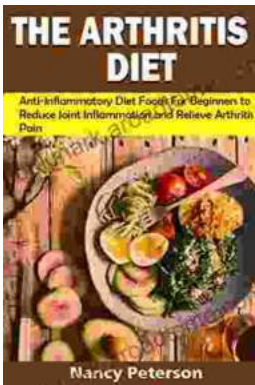

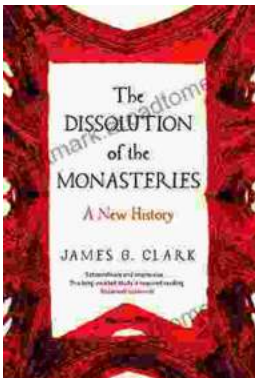
